**WE GUEST PAYMENT, CANCELLATION & REFUND POLICY:** If a guest reservation/booking is cancelled for ANY reason, the right to receive a refund is limited. All cancellations are subject to a \$100 processing (administrative) fee. No refunds will be issued for cancellation notices received within 14 days prior to trip departure (as of Friday, February 1, 2008). Cancellations received more than 14 days prior to trip departure are subject only to processing fee, however, the remaining occupants in the room shall be obliged to pay the difference in the per person room rate. Notification of cancellation **must be submitted in writing** to a WE Official, and shall be effective the date received. All guest refunds will be issued within 30 days of trip conclusion. This event is operated by Private Stock Entertainment (PSE). In the event of inclement weather, war, acts of terrorism, or Acts of God, or any other legitimate conditions arising from causes beyond PSE's control which causes delay or cancellation, PSE will reschedule the trip or issue credit toward another PSE trip. No refunds will be made for trips rescheduled due to conditions arising from causes beyond PSE's control. Cancellation/Refund Policy applies to any booking canceled due to non-payment. PLEASE NOTE: Each booking is treated as an independent (per person) "booking" no matter who has paid the fees.
